Upon the effectuation of Non-SEPA transfer, urgent Euro transfer and urgent Non- SEPA transfer, regardless of the client's BEN, SHA or OUR instruction, the foreign bank may charge additional fees to the ordering party if incomplete or incorrect information about the beneficiary are provided, in which case the transfer cannot be processed automatically. The amount of fees depends on the specific conditions of the respective bank and the fee will be debited from the account of the ordering party.

For transfers in all currencies to EU countries and EEA countries the BEN instruction will change to SHA instruction - VUB, a.s. will debit the fee from the debtor's account.
