

Statute of the “Show us how you enjoy White Night 2019 in Bratislava” competition

This statute of the “Show us how you enjoy White Night 2019 in Bratislava” competition (hereinafter the “Statute”) is a document which bindingly regulates the rules of the competition.

I. Competition announcer

(hereinafter “VÚB, a. s.” or “Announcer”)

* Apple Inc. is not the organiser of the competition.

II. Duration of the competition

The competition runs from 27 September 2019, 12:00 p.m., to 30 September 2019, 12:00 p.m.

III. Competition participants

1. A competition participant may be any natural person who has permanent residence in the territory of the Slovak Republic and is 16 years of age no later than on the day the competition ends (hereinafter the “Competition Participant”).
2. Excluded from the competition are persons who are in an employment or a similar relationship with the Announcers and who are directly involved in any of the following activities related to the operation and organisation of the competition: preparation, processing, and evaluation of data for the purposes of the competition, and identification of the competition winners.
3. Any person who has achieved his/her result in the competition in violation of good morals or applicable law, e.g. by unauthorised interference with the competition mechanism, will be excluded from the competition.
4. If it is established that the beneficiary of this competition is a person referred to in par. 2, Article III, or if it is found that the beneficiary has not been entered in the competition in accordance with the terms and conditions of participation, the beneficiary’s entitlement to the prize will lapse and the prize will be given to a person who has been selected as a substitute. The beneficiary referred to in the first sentence of par. 4, Article III is obliged to pay damages that he/she has caused to the Announcers

IV. Competition rules

1. Competition mechanism

In the competition will be included all Competition Participants who meet the conditions of participation under Article III and who enter the competition by posting a photo on Instagram (<https://www.instagram.com>) that captures them having fun in front of any work of art that is part of White Night in Bratislava with the following hashtag: #vubbielanocBA

Only entries which meet these conditions and which in no way offend the public and the participants will be accepted.

If the winner is a person excluded from the competition under the conditions set out in this Statute, that person’s entitlement to the prize will expire and the person selected as a substitute will become the winner. If none of the

substitutes meets the conditions for participation in the competition, the prize will be forfeited in favour of VÚB, a. s.

If less than 10 (in words: ten) competitors take part in the competition, the prize will be forfeited in favour of VÚB, a. s. The drawing of winners will be carried out in the presence of 2 employees of VÚB, a. s. We will draw 2 winners and 2 substitutes. If this number of substitutes is insufficient, the remaining prizes will be forfeited in favour of VÚB, a. s.

The winners will be notified of their prize through a private message on Instagram.

If the drawn winner (substitute) is not 18 years of age on the day of drawing the prize, the Announcers reserve the right to request the necessary consent of a legal representative to accept and take over the drawn prize.

By participating in the competition, each Competition Participant expresses his/her agreement with the competition rules and conditions set out in this Competition Statute. VÚB, a. s. reserves the right not to hand over or to revoke the prize if the winner has failed to meet or violated any of the provisions of this Statute. VÚB, a. s. will not reimburse the Competition Participants for any costs incurred in connection with the prize, or with meeting the terms and conditions of this Statute. VÚB, a. s. will not be liable for any damages incurred in connection with the prize.

2. Competition prize

3. Competition winner

A competition winner shall be a Competition Participant selected in accordance with the procedure set out in Article IV, par. 1.

4. Informing about the competition results

The winner will be informed about his/her win by VÚB, a. s. via a message on Instagram no later than 3 working days after the end of the competition, under the profile with which he/she joined the competition, provided he/she joined the competition by its end date on 30 September 2019, 12:00 p.m.

V. Method of handing over the prize

The prize will be handed over to the winner by VÚB, a. s. within 20 calendar days from the date of delivery of notification of winning the competition in accordance with par. 4, Article IV of the Statute, and only if VÚB, a. s. receives the winner's electronic statement (a response to the message sent on Instagram) that he/she accepts the prize within 2 calendar days from the date of delivery of notification of winning the competition in accordance with par. 4, Article IV of the Statute. The day of delivery of notification of winning the competition to the winner – for the purpose of determining the start of the 2-day period for sending the statement of the winner under this paragraph – is considered to be the first (1st) calendar day following the date of sending the notification by VÚB, a. s. about winning the competition via Instagram. The handover of the prize to the winner by VÚB, a. s. will be carried out by agreement between the above-mentioned parties.

If VÚB, a. s. within 2 calendar days from the date of delivery of the notification of winning the competition receives a written or electronic statement of the winner that he/she does not accept the prize, or it receives no written or electronic statement from the winner, the prize will be passed on to the substitute. The handover of the prize to the substitute will take place in accordance with Article V, in a similar way to the winner. If neither the winner nor the substitute accepts the prize, the prize will be forfeited in favour of VÚB, a. s.

The winner is responsible for taxing the prize in kind. According to Section 9 (2) (m) of the Act no. 595/2003 Z. z. on Income Tax as amended, the received prize in the value not exceeding €350.00 is exempt from income tax, i.e. the amount of the winnings above the stated amount is subject to income tax and health insurance payments.

VI. Consent to the disclosure of personal data

Information on the processing of personal data is available at www.vub.sk

In order to ensure the course of the competition and to determine the winners, it is the legitimate interest of the Announcers to process the personal data of the Competition Participants to the extent of name, surname, address,

contact phone number, and e-mail address, which need to be stated in the winner's statement that he/she accepts the prize within 2 calendar days from the date of delivery of notification of winning the competition according to par. 4, Article IV of the Statute (in his/her response to the message sent on Instagram).

VII. Right of the Announcer to change the Statute or to revoke the competition

1. Right of the Announcer to change the Statute or to revoke the competition:

The Announcer has the right to change the Statute and/or revoke the competition, especially if the Announcer is at risk of damage.

2. Method of changing the Statute or revoking the competition:

In order for the change of the Statute or the revocation of the competition to take force, the Announcer is required to publish information on the change or revocation at <https://www.vub.sk/ludia/informacny-servis/statuty/> and https://static.bielanoc.sk/2019_statut_sutaze_BA_en.pdf

VIII. Final provisions

1. The Statute enters into force vis-à-vis third parties on the day of the public announcement of the competition at <https://www.vub.sk/ludia/informacny-servis/statuty/> and https://static.bielanoc.sk/2019_statut_sutaze_BA_en.pdf
2. The competition Announcers ensure privacy of the competition Participants and banking secrecy in accordance with the applicable laws.
3. Persons participating in the competition express their agreement with the wording of the Statute.
4. In the event of a conflict of the provisions of the Statute relating to the competition, or uncertainties regarding the interpretation of this Statute, the Announcers have the right to unilaterally correct any ambiguities in the Statute.
5. Relevant provisions of Law no. 40/1964 Coll. the Civil Code, as amended, which are closest in content and purpose, shall apply to any legal relations not regulated by this Statute.
6. The individual participants and the Announcers undertake to solve any dispute arising from or related to this competition by mutual negotiations and agreement.
