

Request for Payout of Dividends from VÚB Shares to Account via Non-Cash Transfer

Notice: Should your personal details (e.g. name, surname, and address) indicated in your valid identity document, presented for purposes of dividend payout (identity card, passport), not correspond to those indicated in Payment Notice related to dividends, you are kindly recommended to either approach the Central Securities Depository of the Slovak Republic, a.s. (hereinafter referred to as the "Central Depository"), or the Central Depository member, depending on which institution holds your security account with request to effect a change prior to claiming the dividend payment. A confirmation certifying the registration of the change in your personal details (e.g. an extract of the basic data from the Central Securities Depository) shall be attached to the Request. If there are any changes in the data about the legal entity, you are recommended to request the relevant institution holding the asset account to change this data prior to claiming the dividend payment and to prove the change when claiming the dividend payment. If the changes to personal data were not recorded in a way as indicated above before the dividend was claimed, the shareholder shall either present an original document or a copy certifying the relevant change when presenting the request for dividend payment in cash or attach the original or copy of such document when payment on account is requested.

Information for heirs: Should a heir to VÚB shares request the payout of any inherited unpaid dividends from VÚB shares, in Part A "Shareholder's identification data" it is necessary to specify in the first half (1) **legator's** personal details (i.e. deceased shareholder) and in the second half (2) **heir's** personal details and (3) registration date of transfer (i.e. signing) of inherited VÚB shares to the securities account held to heir's name, if known.

D. Authentication of identity and signature

This request shall be deemed invalid without your notarized (certified) signature. Should you present this request in person at any VÚB sales point in the Slovak Republic, a VÚB employee will verify your identity and signature free of charge, against the presented identity document (identity card, passport). Should you decide to send this request by post to the above address, your signature shown in the request shall be certified by a notary public or the Registry of Births, Deaths and Marriages at your expense. Should the Shareholder's signature be officially legalized outside the territory of the Slovak or Czech Republic, they have to be super-legalized or certified with an "Apostille" in accordance with the Hague Convention on Legalization of Foreign Public Documents dated October 5, 1961. Legal entities shall be obliged to present an extract from the Slovak Companies register not older than three months. Foreign legal entities shall be obliged to present an extract from the relevant register confirming the existence of the legal entity and the manner of representing the entity not older than three months.
